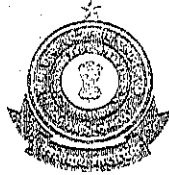

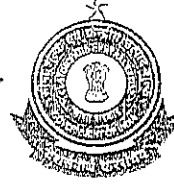
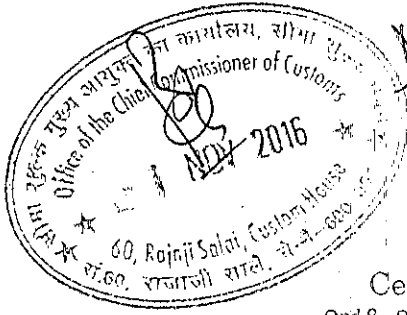

3. All representations received in this regard up to 14.10.2016 stand disposed off.


