



**MINUTES OF THE PERMANENT TRADE FACILITATION COMMITTEE MEETING HELD ON 29.12.2016**

The Monthly meeting of Permanent Trade Facilitation Committee was held on 29.12.2016 at 4.30p.m in the Conference Hall at Room No.517, 5<sup>th</sup> Floor, Ganga Building, Custom House, Chennai - 600 001.

1. The Principal Commissioner of Customs, Chennai-V Commissionerate Shri. Ranjan Kumar Routray chaired the meeting and welcomed the members. The minutes of the previous meeting were circulated among the members for information.

4. In the Meeting Departmental Officials briefed the trade members about the broad framework of upcoming GST regime in Indirect Tax administration and its implication on Customs. In the process it was felt that a detail workshop/Seminar for the trade and various other stakeholders would be beneficial for making all stakeholders ready for upcoming new regime. The Principal Commissioner assured the trade member that the department will soon conduct workshop/Seminar on GST for them.

5. The trade members were also briefed about the benefit of Authorised Economic Operator (AEO) Programme. The Principal Commissioner directed the officials to issue circular to popularise the AEO Programme among various stakeholders like CHS, CFS etc. It was also instructed to make Additional Commissioner of Customs, Chennai-V as Nodal officer for canvassing AEO Programme in Chennai-V Commissionerate.


6. Provisions of Swachata Action Plan (SAP) for Chennai-V Commissionerate was also discussed in the meeting. Cost effective and environmental friendly way of disposing Bio-degradable cargo is one of the actions under SAP which Chennai-V Commissionerate has to implement/undertake.

During discussion some officials raised the issue of difficulty in getting clearance from Tamil Nadu State Pollution Control Board for destruction/disposal of Bio-degradable cargo. The Principal Commissioner directed the Asst. Commissioner-Disposal to quantify the magnitude of Bio-degradable cargo which need disposal and submit a detail report on the whole issue at the earliest.

7. Manager, SANCO CFS raised the issue of their application which they have filed to get official approval for 24X7 Customs Clearance Operation at Sanco Container Freight Station. The Principal Commissioner assured the manager and requested that all such applications should be submitted 7 days (case wise) in advance, so that necessary action can be taken.

8. The Principal Commissioner instructed all officials to achieve the least possible dwell time in official formalities and custom clearance. He also instructed officials to increase facilitation to trade.
