**CIRCULAR NO. 36 / 2017**

Subject: Publication of Draft Seniority List of LOWER DIVISION CLERK in accordance with the provisions of DoP&T's OM Nos. 3514/2/80-Estt(D) dated 07.02.1986 and 220011/7/86-Estt.(D) dated 03.07.1986, as interpreted by Hon'ble Supreme Court of India in the Judgment dated 27.11.2012 in CA No. 7514-7515 of 2005 (N.R.Parmar & Ors Vs. UOI & Ors.)- Reg

1. The committee constituted towards preparation of draft seniority list in compliance with the directions given by Hon'ble Supreme Court of India in the Judgment dated 27.11.2012 in CA No. 7514-7515 of 2005 (N.R.Parmar & Ors Vs. UOI & Ors.) and CBEC's instructions issued vide C. No. A-32022/06/2014-Ad.IIIA dated 08.09.2014 has submitted that all the Seniority Lists in the grade of Lower Division Clerk published after issuance of DoP&T's OM No35014/2/80-Estt(D) dated 07.02.1986 have been re-visited so as to conform to the provisions of inter-se seniority as contained in DoP&T's OMs dated 07.02.1986 and 03.07.1986. The criteria adopted for such revisiting is as under:

I. For Lower Division Clerk recruited, in Chennai Customs House, directly through SSC Exam, the year mentioned in the relevant Examination Name has been taken as the year of availability in terms of the provisions of DoP&T's OMs dt. 07.02.1986 and 03.07.1986 ibid. In most of the cases, the recruitment process for selection of these Lower Division Clerk has been started in that very year with the publication of notification for conduct of examination by SSC.

- II. Among SSC Recruits as per their ranking
  - III. Inter se seniority between SSC Recruits and other mode of direct recruits like Sports quota, Compassionate Appointment and Inter Commissionerate Transferees, date of Advertisement for the examination for SSC recruits and date of joining and order of their merit in the relevant DSCs.
  - IV. SSC recruits were en-blocced above other direct recruits based on the date of notification.
  - V. LDCs recruited through Sports Quota, Compassionate ground appointment and Inter Commissionerate Transferees are arranged as per their order of selection / appointment and kept below the SSC recruits of that year.
  - VI. Inter se seniority between DR and promotees were arranged in terms of instructions in para 2.1 to 2.4 of the DOPT O.M. dated 03.07.1986. Though attempts were made to arrange the seniority as per the rotation of quota based on the ratio of 9 : 1, in view of the directions of the Hon'ble Supreme Court in the above judgment, recruitment year has been determined based on the concept of the initiation of recruitment process against the vacancy, maintaining the ratio of direct recruits and promotees in the prescribed quota rota not explicitly reflected in the enclosed draft seniority list.
2. The draft Revised Seniority List has been prepared on the basis of the information available with Cadre Control. Objection, if any, relating to the revised seniority position assigned to them is to be supported with relevant documents / proof which are to be forwarded to this office latest by 25th May, 2017.
