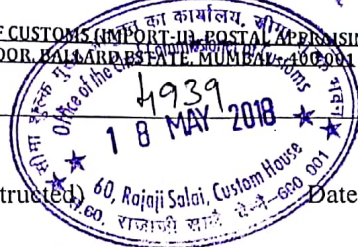
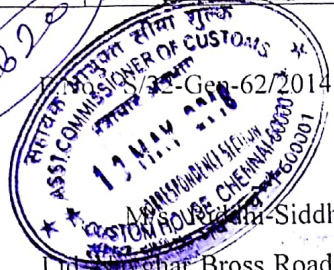

DETENTION NOTICE

Gen-62/2014 PAS(Reconstructed) Riddhi-Siddhi Enterprises having address C-217,Shirdinagar Bldg., No. B CHS Ltd., Navghar Bross Road, Sivsena Office, Bhayender(E), Thane having I.E.C. No.0308029526 and his director Shri Pramod B. Pednekar, having address ,C-133, Saroj Co-opertative Society , Sector-02, Near Sai Mandir, Mira Road(E), Thane have failed to pay the duty amount of Rs. 30,22,828/- Alongwith interest thereon vide confirmed Order-In-Original No.98/JC/PAS/BT/2014-15 dated 29.12.2014 passed by the Jt. Commissioner of Customs, Postal Appraising Section, Foreign Post Office, Mumbai and Order-in-Appeal No. Mum-Custm-SMP-33 to 35/2017 dated 20.06.2017 passed by the Commissioner(Appeal), Mumbai.

Now therefore in exercise of the powers conferred by clause (a) of sub-Section (1) of Section 142 of the Customs Act, 1962, I Piyush Shukla, Dy. Commissioner of Customs,P.A.S. require & request that the aforesaid amount of Rs. 30,22,828/- (Rs. Thirty Lakhs Twenty Two Thousand Eight Hundred Twenty Eight Only) Alongwith applicable interest should be recovered from any money payable to the aforesaid party by the officers of Customs and/or officers of Central Excise(who have also been designated as officer of Customs) all over India. I also further require & request in terms of clause (b) of Section 142 (1) of the Customs Act, 1962 that the amount mentioned above should also be recovered by detaining and selling of any goods belonging to the aforesaid Exporter M/s. Riddhi-Siddhi Enterprises having address C-217,Shirdinagar Bldg., No. B CHS Ltd.,Navghar Bross Road, Sivsena Office, Bhayender(E), Thane having I.E.C. No.0308029526 and his director Shri Pramod B. Pednekar, having address ,C-133, Saroj Co-opertative Society , Sector-02, Near Sai Mandir, Mira Road(E), Thane, which is under the control of officers of Customs and Central Excise (Who have been designated as officers of Customs) all over India. Initiation may kindly be sent to the undersigned as soon as the amount is realized.

The amount so recovered may be sent to the undersigned by Pay Order in favour of A/C RBI , Commissioner of Customs, Mumbai.
