Sub : Special Refunds Fortnight beginning from 16th July to 31st July 2018 – Regarding

Kind attention of Exporters/ Custom Brokers/ Steamer Agents/ Other Stakeholders and the Trading Public is invited to Press release dated 16.07.2018 issued by The CBIC. Refunds of IGST have been a concern for the Government and Trade for the past several months. In this regard, the CBIC has observed two special drives cum refund fortnights in the Months of March, 2018 (15th to 31st March, 2018) and June, 2018 (31st May to 16th June, 2018). The percentage of amount of IGST refund claims disposed by CBIC is already more than 90%.

2. However, in order to liquidate the remaining claims, and to handhold/guide the trade, it has been decided to observe another refund fortnight from 16th July, 2018 to 31st July, 2018. Exporters are requested to make the best of use this drive and avail of the opportunity to get the refunds sanctioned during the special drive. The exporters may contact the dedicated IGST Refund Cell at G403, 4th floor, Ganga Block, Custom House, Chennai-1 or email at igstcuschnai@gmail.com & Phone No. 044-25254250 for the purpose of processing of the pending IGST refund claims.
