The agenda point for this PTFC meeting was same as the last one submitted by the Chennai Customs Brokers' Association.

**Points taken up for discussion:**

**POINT 1 :**

The Secretary of the Chennai Custom Brokers' Association discussed on RECALLINFG RMS FACILITATED BILLS OF ENTRY. The Joint Commissioner informed the trade Association that the matter has been already taken upto re-examine the Para 5 of the Board Circular No: 43/2005-Cus to give the power of recall and amendment to the Deputy/Assistant Commissioners. It is also decided that for minor technical system errors may resolved at the DC/AC level to cut the Dwell time.

**POINT 2:**

The Chennai Custom Brokers' Association informed that they are facing delay in clearance of recalled Bill of Entry after out of charge due to reference of the file to DIU/SIIB in a routine manner. For this Joint Commissioner has informed to the trade that the matter will be brought to the notice of Commissioner VIII, Commissioner III & Chief Commissioner Office to examine the existing Standing Order No. 27/2004 dated 22.03.2004 and the note dated 08.08.2005 & 23.08.2013 issued by S.R. Baruah, Addl. Commissioner of Custom, Systems and R.Anand, Assistant Commissioner, EDI.

**NEW POINT**

The Chennai Customs Brokers' Association also informed that off late containers picked up for scanning are being moved out without scanning with remarks "NOT SCANNED 100% EXAMINATION". When it was enquired they were informed that two containers are loaded in one vehicle which result in overweight and the capacity of scanner is 60 MTs. Due to this the trade is put to hardship. It is suggested by JC that to avoid weight issues, it should be instructed to the terminals to load only one container in one truck for containers in scanning list. Joint Commissioner informed the Trade Association to raise this point in PTFC meeting and with Chief Commissioner and also suggested the Trade association to meet with Deputy Commissioner (Docks Admin) Commissionerate IV/DC(PG) regarding this issue.

After the discussions, the meeting was concluded by the Chairperson thanking all the members who were present in the meeting.
