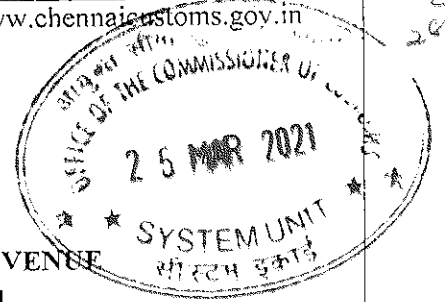

Sub : Conduct of written examination for Form-'G' under Regulation 13 (5) of CBLR, 2018 – Publishing the status of applications – Reg.

In response to Public Notice No. 02 / 2021 – CBS dated 01.02.2021 and Corrigendum dated 05.02.2021 with regard to Form-G examination under Regulation 13(5) of Customs Brokers Licensing Regulations (CBLR) 2018, proposed to be conducted during the month of April, 2021, **643** applications were received by this office.

2. Out of 643 applications, 195 Applications are found to be accepted and remaining 448 Applications were found to have some discrepancies which are earmarked against each, in the Annexure enclosed to this Circular.

3.
