Sub : Issuance of Customs Broker Duty Pass - Covered under Essential Services Maintenance Act, 1968 read with REVENUE AND DISASTER MNAGMENET (DM-IV) DEPARTMENT Notification issued by the GOVERNMENT OF TAMILNADU vide G.O.(Ms) NO.371 DATED 08.05.2021 - Reg.

Kind attention is invited to all the Customs Brokers on the above mentioned subject. In this regard, the Pr.Commissioner of Customs, Chennai, had already written to the Greater Chennai Police Commissioner to enable movement of customs Brokers based on the identity cards issued by Customs, in order to ensure smooth clearance of Customs clearance work at Ports, Airports, Warehouses, etc., Therefore, it is informed that the Customs Broker, shall produce the Identity Cards issued by Customs Authorities, to the Police personnel on being asked. In case of any difficulties faced by them and if they require Duty Pass, for their employees (with minimum bare staff suggested by Govt.of Tamil Nadu), may apply to the Asst.Commissioner of Customs, Customs Broker Section, Custom House, Chennai, in the prescribed format, attached with this Circular. It is also informed that while applying such Duty Pass, the Customs Broker, shall substantiate the reason/grounds for such request.

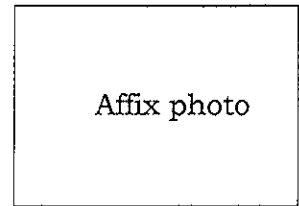
Any mis-use of the CUSTOMS BROKER DUTY PASS, if noticed, the Customs Broker License will be liable for immediate cancellation without giving any reason.
