- 5. Shri R.N.Sekar, President, Chennai Customs Brokers Association (CCBA), stated that of late, the ICEGATE functioning is erratic as none of the Bills are getting numbered after 5.00 PM and they had approached both Principal Commissioner (Air Cargo) & Commissioner (Import) who were extending necessary support. Shri Sekar further stated that there was no message in ICEGATE about downtime and requested that downtime may be integrated / incorporated in the System itself to avoid late filing charges.
- 5.1 Shri R.Srinivasa Naik, Principal Commissioner (General) stated that if it is happening repeatedly, CCBA can give a detailed written representation so that the same can be taken up
