Goods will be sold on 'AS-IS-WHERE-IS' basis.

For all **Scrap** items: Bidders have to bear the cost for providing 'Post Shipment Inspection Certificate from Approved Chartered Engineer for examination of arms, ammunition, radiation, weapons, etc.

For **E-Waste Goods**: Bidders should produce valid registration certificate as recycler of e-waste from PCB etc. The bidders have to produce **PCB as per MOEF guidelines** for participating in the E-Auction of 'Used Rubber Tyres'. **LMPC** is mandatory for all packaged commodities.

Bidders have to bid on lot basis. Items in the list are subject to fulfillment of requirement (if any) i.e. license, registration certificate, etc. The Bidders are directed to inspect the cargo, satisfy themselves with the Cargo Description, Weight and Quantity etc., with Warehouse Staff/Custodian, compliance of all the domestic laws such as BIS, LMPC, EPR, PCB/MoEF/DGFT License/Registration etc. and then take part in the auction. Successful bidders have to pay the GST before taking the delivery of goods as per prevailing taxation rates.
