CIRCULAR -39/2025

Sub: Posting of Air Customs Superintendent (ACS) and Air Customs Officer (ACO) to Anna International Airport, Chennai against 25% quota from Central Excise & CGST Zones and quota from Vizag Customs under Airpool Policy – reg.

Kindly refer to Board's Circulars issued vide F.No.A-11019/102/91-Ad.IV dated 21.10.1993 and vide F.No.A-11019/22/2007-Ad.IV dated 22.12.2008. In terms of the Airpool Policy framed vide the aforementioned Circulars, 25% of the sanctioned strength in the grade of **Air Customs Superintendent and Air Customs Officer** at Anna International Airport are to be filled from CGST & Central Excise Commissionerates.

2. In terms of the Board letter dated 10.11.1997 issued vide F.No.A-11013/12/97-Ad.IV, **03 ACS and 12 ACO** at Anna International Airport, Chennai is to be filled by officers of Vizag Customs.

3. In terms of Para 3(ii) of Board's Circular dated 22.12.2008 issued vide F.No.A-11019/22/2007-Ad.IV, it is stipulated that

"In case where 25% quota of ACS and ACO from the specified outside Customs or Central Excise Commissionerate is not getting filled up, the same shall be extended to all Commissionerate of that category i.e if the outside quota is for Customs Commissionerate, it shall be extended to all the outside Customs Commissionerate and if the outside quota is for specified Central Excise Commissionerate, the same shall be extended to all Central Excise Commissionerates"

4. It is proposed to draw a panel of Superintendents and Inspectors for posting as ACS and ACO respectively at Anna International Airport, Chennai against the 25 % quota from CGST & Central Excise Commissionerates and quota from Vizag Customs under Airpool Policy. At present, the allotment to various CGST & Central Excise Commissionerates (Sl.No. 1 to 12) under 25% quota and Vizag Customs (Sl.No. 13) at Anna International Airport, Chennai is as given hereunder.

* The vacancies allotted to Chennai GST, Hyderabad GST, and Bangalore GST have already been filled.

5. The guidelines terms and conditions as contained in the Air pool policy issued vide Board's letter dt. 15-02-2019 are applicable in respect of selection of the officers. The period of posting at Airport is initially for two years and it may be extended by one more year, subject to the willingness of the officer and acceptance by the Chief Commissioner of Customs, Chennai Zone. However, an officer posted to the Airport can be reverted to his/her parent zone at any time before completion of his/her tenure on administrative grounds. The officers posted at the airport shall be considered as on deputation to the Airport, but no deputation allowance is admissible to them.

7. The following officers are not eligible for posting to Anna International Airport, Chennai
- Officers who have not completed two years of cooling off period after completion of their tenure in DGRIDGEIDGGI)/NCB/Enforcement Directorate/EID or any other International Airport as on date of issue of this letter.
 - Officers who are due for superannuation within two years as on date of issue of this letter.
 - Officers transferred out of Airport/Sensitive postings on administrative grounds.
 - Officers having vigilance cases pending against them.
 - Officers against whom penalty is operative.
8. On receipt of willingness applications from the officers of your Zone, the selection process as contained in the Board's letter F.No.A-11019/16/2018-Ad.IV dated 15/02/2019 may please be taken up and the names of the selected officers maybe intimated to this office on or before 28-07-2025.
9. While forwarding the names, the following documents may please be forwarded.
- Willingness Application
 - Bio Data
 - History of posting
 - APAR Grading for last 5 years
 - Vigilance Clearance certificate
 - Integrity Certificate
 - No Objection Certificate regarding relieving officers in case he/she is selected as ACS and ACO at Anna International Airport.
