4. Shri Rajesh V Shelke, Addl. Commissioner (CCO) welcomed all and stated that Weekly CCFC meeting is being conducted as mandated by the Board and the agenda for this Meeting shall revolve around the prevailing global situation due to the ongoing Gulf crisis. The Addl. Commissioner (CCO) informed that Commissioner (ACC) would chair the Meeting and requested Dr. Manjula D Hosmani, Commissioner (ACC) to Chair the Meeting and deliver the opening remarks. The Chairperson welcomed the participants and asked the Addl. Commissioner (CCO) to continue the proceedings.

5. The Addl. Commissioner (CCO) informed that for today's Weekly CCFC Meeting, no points were sponsored by any Member. The Chairperson asked ADC (CCO) that since no points were sponsored in the last four Weekly CCFC Meetings related to Gulf Crisis, whether Board has been addressed on continuance of this Weekly CCFC Meeting. The Addl. Commissioner (CCO) stated that this has been discussed with the Chief Commissioner of Customs who opined that if there are no points, let us draw 'Nil' Minutes but the Weekly CCFC Meeting has to be held till we receive communication from Board..

5.1 The Addl. Commissioner (CCO) stated that Southern India Consolidators Association (SICA) have mailed a point relating to Back To Town Shipments affected due to disruptions in vessel schedules and transit delays arising from the Strait of Hormuz situation, just before start of this Meeting. The Addl. Commissioner (CCO) further stated that the details furnished in the Mail are not clear and if SICA furnishes the required details, the point may be taken up for discussion in the next Weekly CCFC Meeting.
